We accept the signed and returned dormant letter as activity and you will not be charged this fee.

DORMANT ACCOUNT LETTERS

If there has not been activity in your account for 1095 days you should receive a letter from the Credit Union in the next week or so. New York State abandoned property law requires us to send out these letters to remind you of the account. We appreciate your continued support of the Credit Union. We are not asking you to close your account, we just need activity on the account. Signing and sending back the letter in the self-addressed stamped envelope constitutes activity. Deposits and withdrawals also work.

Those accounts that we receive no response to will be charged the inactive close account fee of \$25.00. Any remaining funds will then be turned over to New York State as abandoned property on November 10, 2024.
